Tax claimed by The Good Exchange Ltd

If you pay Income Tax at the higher or additional rate and want to receive the additional tax relief due to you, you must include all your Gift Aid donations on your Self-Assessment tax return or ask HM Revenue and Customs to adjust your tax code.

The Good Exchange Ltd will pass your donation and any associated Gift Aid to the application you want to support.
